EMPLOYMENT RELATIONS ACT 2007

Wages (Road Transport) (Amendment) Regulations 2022

IN exercise of the powers conferred on me by section 264 of the Employment Relations Act 2007 and on the advice of the Employment Relations Advisory Board, I hereby make these Regulations—

Short title and commencement

1.—(1) These Regulations may be cited as the Wages (Road Transport) (Amendment) Regulations 2022.

(2) These Regulations are deemed to have come into force on 1 April 2022.

(3) In these Regulations, the Wages (Road Transport) Regulations 2015 is referred to as the “Principal Regulations”.

Regulation 4 amended

2. Regulation 4 of the Principal Regulations is amended by—

- (a) in subregulation (1), deleting “second and third column of the Schedule” and substituting “Schedule with effect from the date specified in the Schedule”;
- (b) in subregulation (2), deleting “second and third column of the”; and
- (c) in subregulation (4), deleting “second or third column in the”.
